- I will arrive fully sober** and not under the influence of alcohol, drugs, or any substance that may impair my judgment or physical abilities. Hike Club reserves the right to refuse participation to any guest who appears intoxicated. In such cases, the booking is cancelled with no refund.

- I understand that closed shoes with good grip are mandatory.** Flip-flops, sandals, or open shoes are not permitted. If I arrive without proper footwear, I may be refused with no refund.

- I agree to follow all safety instructions** provided by the guide throughout the hike.

- I understand group hikes depart after 15 minutes**, with no refund if I arrive late. Private hikes wait a maximum of 30 minutes. After this time, the hike is cancelled with no refund.

- I consent to the use of photographs and video** taken during the hike for marketing and promotional purposes.
